## Installation, Configuration and Commissioning of GDC Backup Site Pre-bid Meeting 22 August, 2017 2.30 PM

**1.** The DITT would like to issue following amendments:

- 1. Products including software, should not have reached end of life(EOL) or end of availability(EOA)period. In case the supplied product/software has reached or passed EOL/EOA period, the supplier must supply the product of higher specifications.
- 2. The PDU supplied must have centralised management software. The supplied PDU should be integrated with PDUs at Primary GDC site. In order to ensure compatibility, the PDU supplied should be APC Switched Rack Power Distribution Unit(AP8953).
- 3. Submission of product sample is not required.
- 4. Procurement of VMWare SRM: Cancelled.
- 5. Procurement of NetApp ES2700 Series: Cancelled.
- 6. Distribution Switch: Layer 3 features such as IS-IS and BGP is not applicable.
- 7. Tape Library: Number of LTO drives required is 2.
- 8. Firewall: 1 Gbps VPN throughput, 10000 connections per second.
- 9. VMWare VSphere: The support and service is 3 years.
