ADDENDUM No.-1

The Department of Digital Infrastructure, Government Technology Agency would like to issue the following addendums to the provisions of tender documents floated for the "Supply, Installation, and Configuration of DWDM equipment" on 18th October, 2023 on the GovTech Agency website. The addendum is issued based on the discussion of the Pre Bid Meeting held on 27th October, 2023 at 11:00AM, and decision of Tender Committee Meeting convened on the same day at 12:00AM .

1. Extension of the bid submission deadline: The deadline for the submission of the bid is rescheduled to on or before **16th November, 2023 at 3:00PM.**

2. General Experience: The clause-5 a (ii) under section-III (Terms and Conditions) of document titled Annexure-I (Terms of Reference) is hereby revised to:


*"The bidder should have executed a contract or multiple contracts in any ICT-related works whose total contract value should be minimum of Nu.15 Million. The contract(s) should have been executed within the **same calendar** year in the last 5 years or a single contract value of above Nu.15 million in the last 5 years".*

3. Specific Experience: The clause-5 b under section-III (Terms and Conditions) of document titled Annexure-I (Terms of Reference) is hereby revised to:

*"The bidders must have participated as contractor, supplier, or subcontractor, in at least 1 contract within the last 7 years with value of at least Nu. 15 million that have been successfully or are substantially completed and that are similar to the proposed solution and deployment. The bidder should have executed a contract or multiple contracts whose total contract value should be minimum of Nu.15 Million. The contracts should have been executed within the **same calendar** year in the last 7 years or a single contract value of above Nu.15 million in the last 7 years. The similarity shall be based on the physical size, complexity, method, technology or other characteristics as described in the ToR. In case of the JV, either one of the parties should meet this requirement. The bidders shall provide details of their specific experience records in the relevant form - "Form EXP-2 - Specific Experience" included in the Section IV. The bidders shall submit separate EXP-2 forms for each of their contracts/projects. The bidders shall submit a copy of the work/supply order(s) associated with all their contracts/projects mentioned in the forms EXP-2."*

4. Evaluation Criteria: The clause-1 SN2.2 under table C under section-IV (Evaluation Criteria) of document titled annexure-I (Terms of Reference) is hereby revised to:

" Technical Solution (to be included in the bidder's technical proposal)."
